

GIVING MADE GREATER

There are six primary fund types available at the **Heartland Community Foundation**. Discover our charitable fund options and choose the fund that's right for you. Together, we can create a legacy of generosity and strengthen our community.



Field of Interest

Focus your gift on an important area of community life such as education, health, arts, or environment. You identify your personal interest or passion when making the gift. HCF awards grants to organizations and programs that are making a difference in the area you select.



Designated

Direct your charitable gift to benefit a specific nonprofit organization or purpose. Your gift can provide an ongoing funding stream for a senior center, museum, service provider, or virtually any nonprofit charitable organization, in the area you select.



Donor Advised

Enjoy ongoing involvement with a Donor Advised Fund. Make grants from your fund to any nonprofit organization that supports the causes that matter most to you, including your church or alma mater. Distributions are given in the name of your fund.



Organization

Nonprofits can create permanent endowment funds for their own benefit and receive assistance accepting non-cash or complex gifts. HCF handles all of the administrative and investment responsibilities, freeing the organization to pursue its mission.



Unrestricted

Your gift is highly flexible and available to meet the breadth of community needs — including future needs not yet known. Unrestricted gifts empower Community Foundation staff to make strategic grants, where need and opportunity are greatest.



Scholarships

Invest in your community's future by establishing a scholarship in your name or in honor of a loved one. You determine the criteria students must meet to receive the scholarship. With your help, students can realize their academic and career goals.

POWER OF ENDOWMENT

An endowed charitable fund is a powerful tool, both for you and your favorite charities. This is true for two reasons:

Recurring

Automatically have gifts deducted through our secure giving website. You choose the amount and the duration of giving.

Stock

Donate gifts of appreciated securities, and you may be eligible for a charitable income tax deduction for the full value of the stock, while avoiding the capital gains tax.

Matched

During Match Month, gifts to the HCF County Legacy Funds are matched \$2 for every \$1 for maximum impact.

IRA

Donors age 70 1/2 or older can transfer up to \$100,000 annually from their IRA without being subject to income taxes on the distribution.

Tribute

Make donations to any fund in honor or memory of a loved one. We will notify the honoree or the family of those memorialized.

Planned

Bequests, charitable annuities, charitable trusts, endowments and beneficiary of life insurance or retirement assets are impactful ways to leave a legacy.
