COMMUNITY IMPACT



Pumpkin Patch

When the **Stockton Chamber of Commerce** noticed many families driving long distances out of town to visit pumpkin patches, they decided to create their own pumpkin patch in their own community! They received a grant from the Dane G. Hansen Community Grant Fund to help install a fire pit and benches, as well as purchase some games and props for the event. The fire pit is a permanent addition to the Stockton City Park. The community's hard work paid off, as many out-of-town visitors attended the event! "Because of the funds we received, we were able to get this project up and going," said grantee Jayne Prockish. "Everyone was impressed with the number of volunteers from the community that pulled together and spent countless hours to plan and execute this event. It was an event that the whole family could enjoy and do together, right here in our own town!"

Pickleball & More!

The **Plainville Recreation Commission (PRC)** received a grant from the community foundation to support the expansion of their youth and adult programs. With the grant, they purchased a pickleball set, including paddles, balls, boundary markers, net and a moving cart. Additionally, PRC was able to cover the costs of a third/fourth grade basketball tournament. After-school programs, including art, pickleball and other P.E. games, were also implemented for students who need a structured environment. "The foundation made all of this possible for us to achieve," said grantee Lauren Speer.



Hope Helps Heal

Thanks to support from the community foundation, High Plains Mental Health Center was able to host internationally known mental health advocate and suicide attempt survivor Kevin Hines for a community presentation on August 1, 2018. The event was very successful, drawing almost 700 people, who represented a diverse cross-section of northwest Kansas communities. Many educators, law enforcement officers, attorneys and business professionals attended, as well as community advocates and those who also have stories to share regarding their struggles with mental illness.



Backpacks For Kids

First Call for Help received a grant from the Dane G. Hansen Community Grant Fund to support Backpacks for Kids, a project that ensures Ellis County students have a new backpack, a hygiene pack and many of the school supplies teachers request for the classroom. They shared that one mother cried throughout her trip through the distribution center as she gathered backpacks, shampoo and soap, Kleenex and other items needed for her children's schools. She had recently lost her job and was worried about the needs of her three children as the school year approached. Although the registration deadline had passed, the mother was overwhelmed with gratitude that backpacks and most supplies were still available. She could not say thank you enough.

"Many stories from parents are similar to this one. We hear it all and it makes doing this type of work so worthwhile," said grantee Linda Mills. "None of this would be possible without so much help from volunteers, community, contributors and grants. Thank you."



Frog Fitness

Grant funding allowed **Trego Community High School** to purchase eight Frog Fitness multi-function exercise tools. The machines were received in time to be used during the summer weights program, which is open to USD 208 students in elementary school through 12th grade. "We have been very pleased with the outcome of the grant," said grantee Shea Rothchild. "The frogs have been well-received by our community. Many students and parents were appreciative that the frogs were available for use during the summer, and that they will be utilized throughout the year as part of our K-12 physical education program."

Mental Health First Aid

Several community partners, including Gibson Health Mart, High Plains Mental Health board and Prairie Faith Shared Ministry, worked together to host a Mental Health First Aid Certification course at the WaKeeney Public Library. A community foundation grant helped 35 Trego County community members earn their certifications, lead by Jessica Sherfick and Amy Bird of High Plains Mental Health. "Success was evidenced by the wide variety of community members represented, as well as the total number of participants," said grantee Nancy Bolig. "Success also included the enthusiastic participation in class discussion by those attending and their positive comments about the class."



FOUNDATION INITIATIVES

Dane G. Hansen Match Month Campaign

Through a month-long gift-matching initiative offered by the Dane G. Hansen Foundation, the community foundation was able to raise over \$342,000 for community grants and operations in Rooks, Trego and Ellis Counties. Thank you for contributing to the Twice as Nice Campaign!

During Match Month, donors make gifts to the community foundation to support community grants. These gifts are then matched at a ratio of 1:1.5 by the Hansen Foundation. Up to \$50,000 was matched in each county. These matching dollars support community grants and operations.

Strategic Doing

An initiative of the Dane G. Hansen Foundation and the Heartland Community Foundation, Strategic Doing guides Ellis, Rooks and Trego County residents through the process of prioritizing, planning and implementing sustainable community improvement projects. Projects and ideas that develop from these sessions will be eligible to apply for funding from the Dane G. Hansen Foundation Community Grant Fund at the Heartland Community Foundation or directly to the Dane G. Hansen Foundation. Through a series of open community meetings, participants brainstormed about the strengths, weaknesses, threats and opportunities of the community, then came up with project ideas. Subsequent meetings have included prioritizing project ideas, forming working groups and moving projects forward into action.

TRANSFER OF **WEALTH**

You've enjoyed a good life in a great community. What will you do to ensure the future generations of Ellis, Rooks and Trego Counties can say the same?

Do you know anyone who was born and raised in your community but has since left for a bigger city? Chances are, when this person's parents pass away, the money in their family's estate (which was built in our community) will leave this area forever. By designating just 5% of our estates to our hometown needs, we could create permanent funding to support our schools, hospitals, parks, churches, nonprofits, libraries and so much more! It just takes a little bit of planning.

According to the Kansas Association of Community Foundations:

\$1.2 billion
will pass from one
generation to the
next by **2029**.

5% of that, or
\$60 million
could be preserved
in a foundation
endowment.

This would create
\$2.7 million
in annual grants
to benefit our

PLANNED GIVING

Planning your charitable legacy is simpler than you may think. Donors often establish charitable funds through deferred-giving arrangements—gifts that are planned today and realized upon the donor's passing. There are several ways to support the foundation with planned giving:

Charitable Bequests:

In your will or trust, you direct all or a portion of your estate, including certain money or property, to be transferred to the community foundation.

Life Insurance:

The foundation can be named as the irrevocable beneficiary of your life insurance policy. You can give a paid-up policy or continue to pay premiums.

Charitable Trusts:

Although the foundation does not serve as a trustee for charitable trusts, you can work with your professional advisor to set one up and support the foundation.

Need help with your estate plan?

Professional estate planning services are offered at **no charge** through a partnership with estate planning attorney John Griffin of Stewardship Counseling, LLC.

Once a month, John travels to Salina and provides comprehensive guidance to individuals and families who want to create or update estate plans that minimize potential gift, income and estate taxes. He helps develop the plan; then families work with their local attorney to finalize and file their documents.

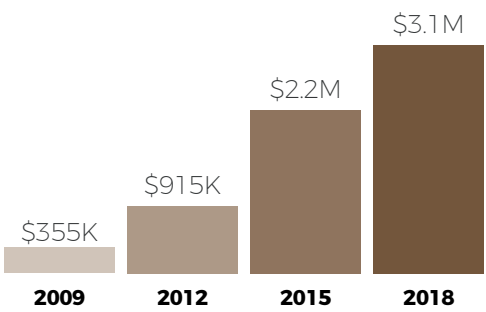

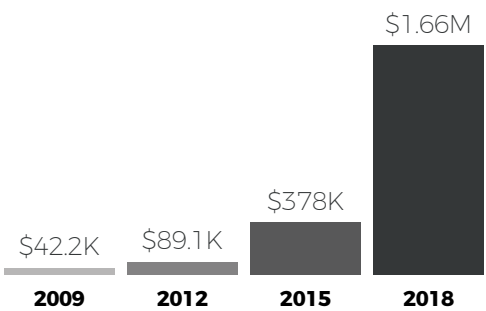

3 Contribute to the Heartland Administrative Fund to support the community foundation's operations.

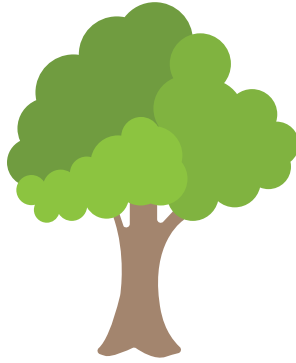
4 Make a gift to the Heartland Area Action Fund, which allows HCF to respond to current local needs.
